# Kalamazoo Valley Museum Board of Advisors Report

The Storytelling Festival and the Fretboard Festival will take place in February and March of 2015. The Museum has issued a Request for Proposal to improve/create a Science, Technology, Engineering, and Math (STEM) Center.

# The Groves Center Board of Advisors' Update

Trustee Schauer, board liaison to the Groves Center Board of Advisors, reported an update from the October 2014 meeting. The inaugural Cell Tower Technician Academy will launch in 2015. A number of additional academies will also take place in 2015. Curt Peterson, Groves Center Advisory board chair, will be retiring in January 2015.

Continuing Status adjuncts will receive 5.75% and Less than Continuing Status adjuncts will receive 3.5% over the life of the contract.

# A RESOLUTION AUTHORIZING THE INITATION OF CONDEMNATION PROCEEDINGS FOR THE PURPOSE OF ACQUIRING LAND NECESSARY FOR CONSTRUCTION OF KALAMAZOO VALLEY COMMUNITY COLLEGE'S HEALTHY LIVING CAMPUS

WHEREAS, Kalamazoo Valley Community College ("KVCC") has established educational facilities in the City of Kalamazoo;

AND WHEREAS, in the development and construction of those facilities it is necessary to acquire real property to provide necessary facilities to enhance educational programs to be conducted at KVCC;

AND WHEREAS, the Board of Trustees of KVCC has determined that there is a public necessity for acquiring the property hereinafter described;

AND WHEREAS, before initiating negotiations for the purchase of the property hereinafter described:

- a. KVCC, through an appraisal process, established an amount that it believed to be just compensation for the property hereinafter described and submitted to the owners of beneficial interests in the property a good faith offer to acquire the property for the full amount established by the appraisal;
- b. The amount of the offer was not less than KVCC's estimate of just compensation for the property hereinafter described; and
- KVCC provided the owners of beneficial interests in the property hereinafter described with an opportunity to review the written appraisal;

AND WHEREAS, KVCC has been unable to negotiate the purchase of the interests in the property hereinafter described, after making said good faith written offer to purchase the property hereinafter described;

AND WHEREAS, KVCC desires to commence an action in the Kalamazoo County Circuit Court to acquire the property.

NOW THEREOFORE, BE IT RESOLVED by the Board of Trustees of KVCC as follows:

1. The Board of Trustees of KVCC deems it necessary to take the private property hereinafter described for public purposes and public uses pursuant to Public Act 331 of 1966, as amended, and Public Act 87 of the of 1980, as amended, namely to provide needed land for the KVCC Healthy Living

Campus in Kalamazoo, Michigan, which is for a public improvement and public purpose consistent with the purposes of KVCC.

- 2. Such taking is a public purpose and public use within the scope of the purpose and powers of KVCC, and is for the use and benefit of the public.
- 3. The Board of Trustees does hereby issue the Statement of Necessity, attached as Attachment A, and incorporated by reference hereto, finding that it is necessary to expand the educational facilities of KVCC in the City of Kalamazoo and that such expansion is for a public purpose and for the benefit of the public. It is further declared and determined that it is necessary for the use and benefit of the public to acquire and take the private property hereinafter described for the public purpose of expanding the KVCC educational facilities in the City of Kalamazoo.
- 4. A description of the parcel of private property that is necessary to be taken for such public purposes and public uses, the names of each known owner of said property, a statement of the estate or interest in the property being taken, and a statement of the sum of money estimated by KVCC to be just compensation for the parcel of property being acquired is provided at Exhibit A.
- 5. By virtue of the authority vested in the Board of Trustees of KVCC pursuant to Michigan Public Act 331 of 1966, as amended, and Public Act 87 of 1980, as amended, it is hereby and now declared and determined that title to property described in Exhibit A is taken by KVCC. A Declaration of Taking is attached as Attachment B, and is incorporated by reference hereto.
- 6. KVCC administration and staff is hereby authorized and directed to retain legal counsel which shall institute such proceedings pursuant to Michigan Public Act 87 of 1980, as amended, and file such documents, declarations, and determinations as may be necessary to effectuate the provisions hereof and to take and acquire the above-described property.
- 7. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution are hereby rescinded.

#### STATEMENT OF NECESSITY

WHEREAS, the development of Kalamazoo Valley Community College's ("KVCC") culinary arts and food innovation programs and the expansion of its health careers programs necessitates the acquisition of fee simple interest in property located in the City of Kalamazoo to accommodate the construction of campus facilities and related site improvements; and

WHEREAS, KVCC has approved a plan to construct certain site improvements through property commonly referred to as Tax Parcel No. 3906-22-222-042.

THEREFORE, IT IS HEREBY DECLARED AND DETERMINED, by virtue of the authority vested in KVCC by law, that it is necessary to acquire a fee simple interest in the following property located in Kalamazoo County, Michigan, for the construction of certain site improvements referenced above:

The Westerly six feet and eleven inches of Lot 41 and the Easterly thirty-six feet and two inches of Lot 42 of the Plat of Garrett and John R. Van Bochoce's Addition to the City of Kalamazoo, according to the plat thereof on file and of record in the Office of the Register of Deeds for said Kalamazoo County.

IT IS FURTHER DECLARED AND DETERMINED that it is necessary to acquire and take the fee simple interest in the aforementioned parcel of land located in Kalamazoo County, Michigan as more fully described in the Description of Taking attached hereto, without the consent of the owners thereof for purposes of constructing certain site and campus related improvements as described above, that said parcel is necessary for the use and benefit of the public, and that good faith offers to purchase said interest in the property have been made; and

WHEREFORE, the attorneys for KVCC are hereby directed to institute condemnation proceedings against the owners and other parties of interest in said private property necessary for the construction of certain site and campus related improvements.

#### **DECLARATION OF TAKING**

A Statement of Necessity having been made by Kalamazoo Valley Community College ("KVCC") setting forth that the acquisition of certain real property located in the City of Kalamazoo, Kalamazoo County, Michigan, which property is more particularly described herein is necessary for the construction of certain site and campus related improvements, and that, as a result, it is necessary to acquire a fee simple interest in said property for public purposes, and that a good faith written offer to purchase said property has been made prior to this Declaration.

THEREFORE, by virtue of the authority vested in KVCC by the Michigan Community College Act, Act 331 of 1966, MCL 389.1 et seq., as amended, and pursuant to the Uniform Condemnation Procedures Act, Act 87 of 1980, MCL 213.51 et seq., as amended, IT IS NOW DECLARED that by the filing of the related Complaint and this Declaration in the Circuit Court for the County of Kalamazoo, fee simple title to the property hereinafter described is taken in the name of KVCC for public purposes. Furthermore, KVCC waives its rights to bring federal or state cost recovery actions against the present owners of the property.

A (a) description of the property interest taken, sufficient for identification, the (b) names of the persons interested in said interest in property so far as is known, a (c) statement of the estate of interest being taken, and a (d) statement of the sum of money estimated by KVCC to be just compensation for the property to be taken, as described above, is as follows:
