# **Update to KVCC Facility related Tobacco Use Policy**

It was **MOVED** by Trustee Patton, seconded by Trustee Gustas, and **CARRIED** that upon recommendation of the President, effective January 2015 KVCC ban tobacco and e-cigarette use on College property with the exception of use in private vehicles.
