#### **ACTION ITEM**

Chairperson Gustas called on Sandy Bohnet, who summarized the highlights of the proposal that the Kalamazoo Valley Community College Faculty Association has agreed to:



• For the second year of the four year contract, the Kalamazoo Valley Community College Faculty Association has agreed to a 1.50% increase for instructional and non-instructional faculty. Faculty below the maximum will be entitled to an equity adjustment. Overload and summer pay will increase by 1.50%. The Faculty Association also agreed to participate on a committee with staff and administrators to evaluate alternatives to the medical, dental and vision and prescription drug coverage currently in effect. The contract will be reopened sometime after November 1, 2015 to discuss compensation and benefits for the remaining two years of the contract.

It was **MOVED** by Trustee Schauer **SECONDED** by Trustee Young and **CARRIED** to endorse the Agreement between Kalamazoo Valley Community College and the Kalamazoo Valley Community College Faculty Association, effective June 30, 2015.
