ACADEMY SCHEDULE:

The Kalamazoo Valley Law Enforcement Training Center Police Academy is a 18 week, full-time program, typically scheduled Monday through Friday, 6:00AM – 4:30PM. However, in addition, some training is scheduled nights and weekends as needed. It is a very demanding program and MCOLES requirements allow for very little time away during the 18 week session. For this reason we strongly suggest you do not plan to work during your time in the Academy if at all possible. You will also need to allow for significant study time and additional physical training outside of the scheduled Academy hours.

DEGREE REQUIREMENT OR COLLEGE CREDITS EARNED TO ENTER THE ACADEMY:

To be eligible to enter the Academy you must possess an Associate degree or higher OR completion of the Academy (34 hours awarded upon successful completion) must earn you the Associate degree when combined with your previous college credits earned. We refer you to the KVCC Admissions/Registration/Records office for evaluation of your status/eligibility. AGE REQUIREMENT:

Minimum of 18 years of age to enter the Academy.
