- To be eligible for a student loan, TIP, or work study, you must be enrolled at least half-time — 6 or more credit hours.
- If you are not registered for summer classes by May 24, 2024, the first time you do register for summer classes, that date will be your freeze date. This means if you were awarded a Pell Grant, this will not increase for any additional classes you register for after this freeze date.
- **Courses must be required for your program of study.**
