- * Each Scholarship is for \$500.00
- * This is one-time only scholarship per person
- * This scholarship will be decided by a panel of community veteran advocates
- * Deadline is July 31st, 2013, 5:00PM—No Exceptions
- * Scholarship money will go directly to applicant
- * Scholarship will be awarded on or around August 31st, 2013
