

Kalamazoo Valley Community College Scholarship Information Guide Including Federal and State Financial Aid Programs

The Financial Aid Office at Kalamazoo Valley Community College processes numerous scholarships each year. Funding for the scholarships listed in this guide, is provided by Federal, State, Institution, private sources, and the Kalamazoo Valley Community College Foundation.

The purpose of this Scholarship Information Guide is to acquaint you with the various scholarships that are offered through our Financial Aid Office. A brief description is given of each scholarship. Depending on the availability of funds, some scholarships listed in this guide may not be awarded on an annual basis. New scholarships may also become available during the award year.

Applications for scholarships listed in this guide will be accepted only when funds are available and the scholarship is posted. To determine scholarship availability status, access the KVCC Financial Aid web site at www.kvcc.edu/financial or contact the Financial Aid Office.

In addition to the scholarships listed in this guide, many aid dollars are made available through local social groups, professional associations, civic organizations, business concerns, churches, unions, etc. Private funds vary greatly from community to community. We encourage you to do the following to determine if scholarships are available to you:

The following scholarships are offered to students at KVCC. Students can apply for these scholarships once they are promoted and funding is available.

JANET G. ALIKINS MEMORIAL ENDOWMENT SCHOLARSHIP – Eligible applicants must be enrolled in the Business Administration program and have completed a minimum 24 credit hours at KVCC with a 2.5 GPA. Documented need required.

ANDERSON GRANT - Eligible applicants must be enrolled at least three-quarter-time (minimum of 9 credit hours) and have completed a minimum of 6 credit hours at KVCC with at least a 3.0 GPA. Documented need required.

ARCADIA ALES BREWING SCHOLARSHIP - Eligible applicants must be enrolled at least half-time (minimum of 6 credit hours) in the Sustainable Brewing Program and have completed a minimum of 6 credit hours in the brewing program. Must have a minimum 3.0 GPA. Documented need required.

RACHAL J. BADRA MEMORIAL KVM INTERN STIPEND – Open to all college students who have at least a high school diploma or its equivalent. Preferred academic interest in museum studies, history, science, education, graphic and computer arts, but all disciplines considered based on project needs and long-term goals of the Museum. Must be self-motivated independent worker able to conduct research and write on related projects. Most internships are structured around one major project with the expectation that the project shall be completed at the conclusion of the internship. Preference given to KVCC student.

NONA & RICHARD BARRON MARKETING ENDOWED SCHOLARSHIP - A scholarship funded by Nona and Dick Barron for business students studying marketing. Mr. Barron is a retired faculty member of KVCC. Eligible applicants must be enrolled in a marketing program, and have completed a minimum of 18 credit hours at KVCC with a minimum 3.0 GPA. Applicants must be currently enrolled for a minimum of 9 credit hours. Preference will be given to non-traditional students currently working. Documented need required.

RAYMOND E. BATTILANA ENDOWED SCHOLARSHIP - Funded by and named for Raymond E. Battilana, a trustee of the Kalamazoo Valley Community College Foundation from 1990 to 1999.

SCOT BEYERSTEDT MEMORIAL SCHOLARSHIP – Eligible applicants must be accepted in the Police Academy. Pre-service academy status required, and must achieve an outstanding rating from the Academy pre-admissions oral interview. Must be a permanent resident of Kalamazoo County or Van Buren County. A minimum B band score is required on the MCOLES pre-employment test.

EDWARD AND CLAUDIA BLAHNIK SCHOLARSHIP – Eligible applicants must not be “Kalamazoo Promise” eligible. Must be enrolled in a Drafting or technology-related program. Must be enrolled at least half-time (minimum of 6 credit hours) and have a minimum 2.5 GPA. Must have successfully completed the first semester of their program.

BRIDGESTONE/FIRESTONE, INC. SCHOLARSHIP FUND - Funded by Bridgestone/Firestone Trust Fund. To aid students enrolled in the Automotive Technology Program who have a minimum 2.0 GPA

LEONARD L. BRIDGE MEMORIAL ENDOWED SCHOLARSHIP - A scholarship named in memory of a former KVCC coach and long-time faculty member. Eligible applicants must be a student athlete at KVCC and have a minimum 2.0 GPA. Documented need required.

BRONSON EMPLOYEES' EDUCATION SCHOLARSHIP FUND - This scholarship program is designed to assist eligible Bronson employees with documented costs associated with attending KVCC.

CHAR AND TOM BROUWER MEMROIAL SCHOLARSHIP - A scholarship named in memory of a KVCC employee and her husband. This scholarship is funded annually by friends and loved ones in their memory. Eligible applicants must be Michigan residents and admitted to the Level II Nursing program. Applicants must be enrolled for at least three credit hours and have a minimum 2.0 GPA. Applicants must document current community/volunteer activities, including the dates of these activities. Financial need must be described on the scholarship application. Documented need required.

THE BURDICK-THORNE SCHOLARSHIP FUND – A scholarship to benefit students demonstrating financial need, who are enrolled at least half-time.

CHEMICAL BANK SCHOLARSHIP - Eligible applicants must be enrolled at least half-time (minimum of 6 credit hours) and have completed at least 36 credit hours at KVCC with a minimum 3.0 GPA. Must not be on satisfactory academic progress suspension status. Applicant must submit a statement regarding the Importance of Community Volunteerism and two letters of recommendation. Documented need required.

R.M. AND JOHN COLLINS ENDOWED NURSING SCHOLARSHIP - Funded by the family to establish an endowed nursing scholarship in memory of Rena Marceil Collins. Eligible applicants must be enrolled in the Nursing program and have completed at least 12 credit hours at KVCC with a minimum 3.0 GPA. Must be currently enrolled in a minimum of 6 credit hours. Documented need required.

H.P. & GENEVIEVE CONNABLE SCHOLARSHIP – Eligible applicants must be enrolled in a minimum of 6 credit hours. No minimum GPA is required, however, a 2.0 GPA is required for applicants reapplying for a continuing award.

NORMA B. CONANT MEMORIAL SCHOLARSHIP- The family and friends of Norma B. Conant have established this memorial award for Dental Hygiene students.

CONSTRUCTION FINANCIAL MANAGEMENT ASSOCIATION OF SW MICHIGAN - Eligible applicants must be pursuing a program related to the construction trades and have a minimum 2.8 GPA.

JANIS SCOTT CRANDALL DENTAL HYGIENE SCHOLARSHIP – Eligible applicants must have successfully completed the first year of the Dental Hygiene Program, have a minimum 3.0 GPA and demonstrate financial need.

MATT CYGAN MEMORIAL AITP SCHOLARSHIP - Eligible applicants must be a member of AITP and must attend the annual AITP conference. Must have completed a minimum of 12 credit hours at KVCC and have a minimum 2.5 GPA. Must be enrolled for at least 6 credit hours. Applicants will need to submit an essay summarizing their experience at the AITP conference.

MARY AND ELLIOTT DEMEYER FUND FOR EDUCATION – This fund is available to meet the unforeseen needs of students. Preference is given to students residing within the KVCC service district.

PAUL AND HEATHER ELWELL SCHOLARSHIP - Eligible applicants must be enrolled in a transfer program and plan to transfer to a 4-year college or university and plan to major in finance or economics. Applicant must be currently enrolled full-time, have a minimum 2.0 GPA based on a minimum completion of 12 credit hours, and be in good standing. Must be a Michigan resident. Documented need required.

RICHARD M. EUSTICE FAMILY EDUCATIONAL FUND – Eligible applicants must be enrolled in a health-related program. Must have completed at least 24 credit hours at KVCC and have a minimum 3.0 GPA. Must be a Portage Public School graduate with preference given to Portage Northern.

CHARLES W. AND MARJORIE EWALD SMITH ENDOWED SCHOLARSHIP - This endowed scholarship was established by Charles W. and Marjorie Ewald Smith in memory of Donald Francis Smith. Eligible applicants must be enrolled in one of the following programs: Business, Health Careers, Human and Public Service Careers, Technical and Industrial Careers or Elementary Education. Applicants must be enrolled at least half-time (6 credits) for the semester and have completed a minimum 12 credit hours at KVCC with a 2.0 GPA. Preference will be given to Van Buren County residents. Documented need required.

FINAL GRAVITY SUSTAINABLE BREWING SCHOLARSHIP- Eligible applicants must be a first-year student enrolled in at least one class in the Sustainable Brewing Program. Applicants must submit an essay of 500 words or less stating why they chose the KVCC Sustainable Brewing Program. Documented need required.

GARY SISTERS FOUNDATION SCHOLARSHIP - This scholarship is funded by a bequest from three sisters who were concerned about education in Kalamazoo. Eligible applicants must have a minimum 2.0 GPA. Non-traditional students and students with special circumstances are encouraged to apply.

GIL AND SYLVIA GOLDE ART SCHOLARSHIP – Current KVCC students must be enrolled in the Certificate or Associates degree in Illustration or Animation programs. High school students must have intention of enrolling in the KVCC Illustration or Animation program for the upcoming fall semester and must provide a letter of recommendation from their high school art instructor. All applicants must upload a digital portfolio consisting of 6-12 pieces of art. Applicants must also submit a 750 word or less essay answering these questions: What are your goals? What is your inspiration? Why are you following the Illustration, Animation or Fine Arts for your transfer path?

GONZO'S BIGDOGG BREWING SCHOLARSHIP – Eligible applicants must be enrolled full-time (12 credit hours) in the Sustainable Brewing Program. Must have completed a minimum of 4 credit hours in brewing/culinary programs and have a minimum 3.0 GPA. Applicant must submit essay (200 words or less) stating: “why are you applying and what would receiving this scholarship mean to you”. Documented need required.

FRANK A. HEATH AND JANE S. HEATH MEMORIAL SCHOLARSHIP - A scholarship awarded in memory of Dr. Frank Heath and Jane Heath to an outstanding dental hygiene student.

STANLEY & BERTHA HOGARTH ANNUAL NURSING SCHOLARSHIP – This scholarship is funded through a gift from the Bertha Hogarth Estate. The Nursing Department selects the recipient for this annual scholarship based on the following criteria: student must have completed the first year of the KVCC Nursing Program, be enrolled in the second year of the KVCC Nursing Program, have a high GPA and be in good standing. Preference will be given to the candidate that demonstrates excellence in pursuit of a nursing degree.

HOUSING RESOURCES, INC. SCHOLARSHIP FUND - A scholarship funded by Housing Resources, Inc. for their clients to attend Kalamazoo Valley Community College.

THERESA HOLLOWELL AND FRIENDS DENTAL HYGIENE SCHOLARSHIP- Eligible applicants must be enrolled in the Dental Hygiene program and have successfully completed 16 credit hours at KVCC. Applicant must provide an essay of 500 words or less as to what this award would mean to them. Documented need required.

PAUL AND MARY JACKSON ACHIEVEMENT AWARD - The family of Paul D. and Mary G. Jackson have established this award for their parents, grandparents and great-grandparents in recognition of Mr. Jackson's long affiliation with KVCC as a founder and original board member. This achievement award recognizes an outstanding student at KVCC. This award requires academic excellence, high standards of citizenship, participation in extra-curricular activities, community involvement, and model work experience. Applicant must have been enrolled full-time for the majority of her/his studies at KVCC. Applicant must also file a graduation petition for the upcoming May graduation by the time of application for this award.

PAUL AND MARY JACKSON ENDOWED SCHOLARSHIP - This scholarship is named after Paul D. Jackson who is one of the founders of KVCC and served as treasurer on the original Board of Directors at the College. His two children gifted the scholarship funds donated by family and friends as a 50th year wedding gift to their parents. Eligible applicants must be enrolled for at least 6 credits and have a minimum 2.0 GPA.

KALAMAZOO ANTIQUE AUTO RESTORERS CLUB SCHOLARSHIP – Eligible applicants must be enrolled in the KVCC Automotive Technology program. Must have a 2.5 or higher GPA. Must have at least 12 credit hours in the Automotive Technology program completed and be enrolled in at least one automotive class for the semester. Recipients of this scholarship must attend one KAARC monthly meeting to talk about the Automotive Technology program before the scholarship is actually awarded.

KALAMAZOO VALLEY MERIT SCHOLARSHIP – High school seniors may apply for this scholarship. Awards are based on students' academic achievement. Student must have a minimum 3.5 GPA and a minimum ACT Composite score of 21 to be eligible for consideration.

KVCC FACULTY ASSOCIATION SCHOLARSHIP - This scholarship award is given by the KVCC Faculty Association to assist an eligible student with direct college costs. Eligible applicants must have completed a minimum of 18 credit hours at KVCC, and be currently enrolled for a minimum of 6 credit hours for the winter semester. Applicant must have a minimum 3.0 GPA. In addition to completing a scholarship application, applicants must also submit one letter of recommendation from a KVCC faculty member or non-family member, and submit a scholarship project. The scholarship project is to address “The Importance of Education Today.” It may be done in any format (written essay, artwork, audio-visual material or a combination). It is a means for the applicant to express his/her viewpoint on this important topic.

KVCC FOUNDATION STUDENT ASSISTANCE GRANT -The KVCC Foundation established this fund to provide financial assistance to students.

KVCC TRUSTEE ACHIEVEMENT AWARD FOR HIGH SCHOOL/ADULT EDUCATION GRADUATES – Students are nominated by their high school counselor, principal, or instructor. Awarded to graduating high school seniors or adult education students from an in-district high school or adult education center. Must be planning to enroll at Kalamazoo Valley at least half-time for the following fall semester.

KVCC TRUSTEE ACHIEVEMENT AWARD FOR EDUCATION FOR EMPLOYMENT (EFE) - Awarded to graduating seniors who participated in an Education for Employment course through KRESA. Students are nominated by an instructor and selected by a Kalamazoo Valley Community College Scholarship Committee. Must be planning to enroll at Kalamazoo Valley at least half-time for the following fall semester.

KVCC TRUSTEE ATHLETIC SCHOLARSHIP - KVCC provides funds for scholarships to selected athletes participating in intercollegiate athletic events scheduled by the College.

KVCC TRUSTEE ASSISTANCE FUND - KVCC established this fund to provide financial assistance to students.

KVCC TRUSTEE HONORS PROGRAM SCHOLARSHIP - KVCC provides scholarships annually to students selected for the Honors Program who are working toward an Associate Degree in any field. Honors students have high GPAs, ASSET scores, and letters of recommendation. They are required to take honors classes and participate in community activities, including volunteer work. Applications are available from the Honors Office (Room 7363).

JOHN LASOTTA MEMORIAL SCHOLARSHIP – Funded by memorial gifts from family, students and colleagues in honor of John LaSotta, former Dean of General Studies. Eligible applicants must have a minimum 3.0 GPA. Documented need required.

ROSALIE CLAUWAERT LLOYD MEMORIAL SCHOLARSHIP FUND FOR NURSING EDUCATION - A scholarship awarded annually to nursing students showing compassion, sensitivity and commitment to the ideals of the profession of nursing.

DAVID B. AND JEANNE M. LONG SCHOLARSHIP - This scholarship is funded by David and Jeanne Long and is available to non-traditional students enrolled at least half-time, who demonstrate financial need.

LYNCH SCHOLARSHIP - This scholarship was developed in support of a student with the desire to work in the area of Industrial Trades/Engineering, Design & Manufacturing Technology. Eligible applicants must be enrolled in the Industrial Trades/Engineering, Design & Manufacturing Technology program. Must have completed at least 12 credit hours at KVCC and not be on financial aid suspension. Applicant must submit essay of 500 words or less stating why they chose the trades program. Documented need required.

RICHARD MARGELIS MEMORIAL SCHOLARSHIP – Eligible applicants must be enrolled in a Science or Health-related Program. Must be enrolled full-time and have completed at least 12 credit hours at KVCC and have a minimum 3.0 GPA. Documented need required.

CAROLL F. & LUNA P. MARQUARD MEMORIAL NURSING SCHOLARSHIP – Eligible applicants must be in their second year of the KVCC Nursing program. Must be a U.S citizen or permanent legal resident. Must have a minimum 3.0 GPA and demonstrate superior clinical skills and consistency in providing compassionate care for patients.

MILLER-DAVIS COMPANY ENDOWED ENGINEERING TECHNOLOGY SCHOLARSHIP - Eligible applicants may be pursuing any program of study, but consideration will be given to students taking engineering technology programs and/or planning to transfer to Western Michigan University's Civil Engineering or Construction Engineering programs. Must be a Michigan resident and have completed a minimum of 12 credit hours at KVCC and have a minimum 3.0 GPA. Must be enrolled full-time. Documented need required.

HARRY AND RHODA MOHLER MEMORIAL SCHOLARSHIP - An endowed scholarship funded in memory of Harry and Rhoda Mohler by their family. Eligible applicants must be pursuing a health-related program and have a minimum 3.0 GPA. Documented need required.

MOL-SON, LLC & WESTERN DIVERSIFIED PLASTICS, LLC SCHOLARSHIP - A scholarship funded annually by the two companies for a student in a Technical and Industrial Career program (CAD Design, CAD-CAM Design, Machine Tool Automation or Mechanical Engineering Technology). Must be a Michigan resident who has completed at least 21 credits at KVCC and be enrolled for a minimum 9 credits for the semester. Preference given to non-traditional students currently working full or part-time. Documented need required. Recipients of this scholarship are required to set-up a company visit.

JOANN NEMECEK MEMORIAL NURSING SCHOLARSHIP – A scholarship for students who have successfully completed the first semester of the nursing program.

THE NOVA STAR SCHOLARSHIP – Eligible applicants must be at least 24 years old and be enrolled in a minimum of 6 credit hours. Must have completed at least 6 credit hours at KVCC and have a minimum 2.5 GPA. Must submit an essay explaining their need for this scholarship. Documented need required.

THOMAS OBERLINK MEMORIAL SCHOLARSHIP – Eligible applicants must be in-district students pursuing a Liberal Arts Degree and have a minimum 3.0 GPA. Applicants must have completed at least 12 credit hours at KVCC, and be currently enrolled full-time. Documented need required.

RICHARD A. OLIVANTI ENDOWED SCHOLARSHIP- A scholarship named and funded in honor of the retirement of the Vice President for College Relations by friends, family and business associates.

ONE WELL BREWING SCHOLARSHIP – A scholarship for students who are enrolled at least half-time (minimum of 6 credit hours) in the Sustainable Brewing Program. Applicant must have completed a minimum of 6 credit hours in the brewing program and have a minimum 3.0 GPA. Applicant must also submit essay of 500 words or less stating why they chose the KVCC Sustainable Brewing Program. Documented need required.

KATIE AND FRED OPPEL SCHOLARSHIP - Eligible applicants must be a learning different student and must self-report the learning difference and provide official documentation of the learning difference. Applicant must provide a brief biography identifying their learning difference and include strategies and accommodations they have used in the past to help them succeed and what makes them a candidate for this award. Student should have a minimum 2.0 GPA. Preference will be given to a student athlete first, and then preference to student with financial need.

OSHTEMO ROTARY CLUB SCHOLARSHIP - This scholarship is funded by the Oshtemo Rotary Club. Eligible applicants must be enrolled at least half-time and have completed at least 12 credit hours at KVCC and have a minimum 3.0 GPA. Must also be a resident of Oshtemo Charter Township. Documented need required.

PERKEY INTERN SCHOLARSHIP - This scholarship was established to assist students with expenses while participating in internships at KVCC. Eligible applicants must be currently enrolled in an internship course through KVCC. Applicant must have completed at least 42 credit hours at KVCC with a minimum 2.5 GPA and be enrolled in at least 6 credit hours.

PATCHELL FAMILY SCHOLARSHIP - Eligible applicants must be enrolled in an Education program of study (Elementary, Secondary or Special Education). Must have completed a minimum of 12 credit hours at KVCC and have a minimum 3.0 GPA. Documented need required.

PNC CULINARY SCHOOL ENDOWED SCHOLARSHIP –This scholarship is available to eligible applicants who are enrolled in the Culinary School program. Applicants must submit a 300 word or less essay summarizing why they are enrolled in this program, and the obstacles or challenges facing them while enrolled.

RENE (BILL) PENNY MEMORIAL NURSING SCHOLARSHIP - This scholarship is available to students enrolled in the second year of the Nursing Program.

DR. CALVIN PETERS SCHOLARSHIP – Eligible applicants must be pursuing a program of study in one of the following areas: Human Services, Social Work, Teaching, Health Careers. Applicants must have completed at least 24 credit hours at KVCC with a minimum 3.0 GPA. Preference given to students pursuing a Bachelor and above degree. Documented need required.

CONNIE AND GENE PHIPPS ENDOWMENT FUND – Eligible applicants must be enrolled in the LPN or RN nursing program in the fall. Applicants must show compassion and sensitivity, and are truly dedicated to the nursing profession. Preference will be given to students whose GPA is 3.5 or below. Documented need required.

PILOT MALT HOUSE SCHOLARSHIP FOR SUSTAINABLE BREWING – Eligible applicants must be enrolled in the Sustainable Brewing Program. Documented need required.

CARL RASMUSSEN VOCATIONAL TECHNICAL SCHOLARSHIP - This endowed scholarship is funded by Kalsec, Inc. Eligible applicants must be pursuing an AAS degree in one of the following careers: Business, Human and Public Service, Health, or Technical and Industrial. Eligible applicants must be in-district and be enrolled full-time, have completed a minimum of 24 credits at KVCC, and have a minimum 2.5 GPA. Applicants must submit an employment resume and two letters of recommendation (Letter from a faculty member and another from a non-family member).

WILLIAM F. AND JEAN E. REEVES ENDOWED SCHOLARSHIP - An endowed scholarship funded in honor of his parents, by Frederick Reeves, a Trustee of the Kalamazoo Valley Community College Foundation.

FRED AND VBELMA REYNOLDS SCHOLARSHIP - This award recognizes a student interested in improving self, who was unable to enroll in college without community college-related services (assessment, tutoring, counselling, developmental courses, etc.), and who is determined and committed to completed his/her program. Eligible applicants must have completed a minimum 24 credits at KVCC, be enrolled full-time and have a minimum 2.0 GPA. Must be enrolled in a transfer program. A letter from a KVCC official verifying need and use of community college services is required. Documented need required.

RILEY-SHURTE ENDOWED SCHOLARSHIP - An endowed scholarship funded by the estate of Patricia Riley. This scholarship is available to students enrolled at least half-time and have at least a minimum 2.0 GPA.

ALFRED AND MARY SAGAR SCHOLARSHIP – Eligible applicants must be a non-U. S. citizen or non-resident. (Not for students of foreign origin who are on immigrant visas). Must be enrolled for at least 12 credits or plan to finish a program of study.

KATHRYN AND OLIVER SHIELDS ENDOWED SCHOLARSHIP - A scholarship to benefit students demonstrating financial need in the career-vocational programs.

SOUTHERN MICHIGAN BANK & TRUST SCHOLARSHIP - Eligible applicants must be U.S citizens enrolled full-time in a program within Accounting, Business, or Computer Information Systems. Must have completed a minimum of 18 credit hours at KVCC and have a minimum 3.0 GPA. **Documented need required.**

TERRY AND CYNTHIA STEWART FAMILY ENDOWED SCHOLARSHIP – Eligible applicants must be at least 24 years of age at time of application and be an in-district, U.S. citizen. Applicants must have completed a minimum of 12 credit hours at KVCC with a minimum 2.0 GPA, and be currently enrolled for a minimum of 6 credit hours. Documented need required.

STONER/SCHMIEGE WIND TURBINE TECHNOLOGY ACADEMY – Eligible applicants must be enrolled in the Wind Turbine Technology Academy. Student must be highly motivated and show early dedication and commitment to the program. Student must submit a 100 word or less essay summarizing why they are enrolled in this program, the obstacles or challenges facing them while enrolled in the academy. Documented need required.

STUDENT CAFÉ AND RESTAURANT CULINARY SCHOLARSHIP- This scholarship was established by the Culinary AAS program and students operating the Havirmill Café and 418 Restaurant. Eligible applicants must be enrolled in the Culinary Arts and Sustainable Food Systems Program and have completed a minimum of 20 credit hours in this program. Must be enrolled in at least 6 credit hours in the culinary program and have a minimum 2.6 GPA. Documented need required.

JAMES WM TAYLOR RESPIRATORY CARE SCHOLARSHIP - Eligible applicants must be enrolled full-time in the Respiratory Care Practitioner Program. Must have completed a minimum of 12 credit hours at KVCC and have a minimum 3.0 GPA. Documented need required.

DIXIE THOMAS MEMORIAL SCHOLARSHIP – This scholarship is designed to assist students in a health-related program, with books and supplies.

TOWERPINKSTER ARCHITECTS/ENGINEERS SCHOLARSHIP- Eligible applicants must have completed a minimum of 24 credit hours – includes transfer credits. Must be enrolled full-time and have a minimum 3.0 GPA. Preference will be given to in-district students and preference to those students enrolled in the following programs: Architecture Associate of Science, Engineering Associate of Science, CAD Specialist Certificate, Computer-Aided Design Associate of Applied Science or Engineering Technology Associate of Applied Science. Documented need required.

TRACY EMS SCHOLARSHIP – Eligible applicants must be enrolled in the EMS Health Sciences program full-time. Must have completed a minimum of 12 credit hours at KVCC and have at least a 3.0 GPA. Applicant must submit essay of 100 words or less addressing prior experience as a healthcare provider and how they want to make a difference in emergency settings as a healthcare provider. Preference will be given to those with prior experience as a healthcare provider.

VANBUREN F.O.P. SCHOLARSHIP – Eligible applicants must be a Van Buren County resident and be accepted into the Police Academy. Must achieve an outstanding rating from the Academy pre-admissions Oral Interview and have a minimum B band score required on the MCOLES pre-employment test.

EDWARD AND VIRGINIA VANDALSON SCHOLARSHIP ENDOWMENT FUND - Eligible applicants must have completed a minimum of 24 credit hours at KVCC with a minimum 3.5 GPA. Must be currently enrolled in at least 6 credit hours. Documented need required.

RICHARD VANVRANKEN MEMORIAL ENDOWED SCHOLARSHIP – Eligible applicants must be Galesburg-Augusta High School graduates, enrolled at least half-time for the fall semester. Applicants must have completed a minimum of 12 credit hours at KVCC with a minimum 3.2 GPA. Preference will be given to students currently employed a minimum of 15 hours a week. Documented need required.

SPASA AND SLAVA VOYNOVICH ENDOWED SCHOLARSHIP - This endowed scholarship is funded by Mr. Spasa Voynovich. Applicant must submit an essay on "The Development of Society" to be judged by a Scholarship Committee.

WEBER SPECIALTIES COMPANY SCHOLARSHIP – Eligible applicants must be in a Welding or Machine Tool program and have a minimum 2.0 GPA. Applicants must also indicate if they have a parent employed at Weber Specialties.

MARION M. & LEO F. WERNER ENDOWED NURSING SCHOLARSHIP- This award established in honor of Marion M. Werner, is made available to assist eligible nursing students with the semester cost of books and supplies.

WESTERN MICHIGAN MOPAR CLUB SCHOLARSHIP - Eligible applicants must be enrolled at least half-time (minimum of 6 credit hours) in the Automotive Technology (Undercar or Drivability Systems) program and have completed at least 24 credits that include a minimum of 5 classes in the Automotive Technology program. Must be a U.S. citizen and have a minimum 3.0 GPA. Recipient of scholarship is also encouraged to attend the KVCC Automotive Department Open House. Documented need required.

ANNA WHITTEN HUMANITARIAN SCHOLARSHIP - Eligible applicants must be a resident of Kalamazoo or Port Huron, Michigan. Must have completed at least 24 credit hours at KVCC with a minimum 3.0 GPA. Applicant must summarize and provide their community and/or volunteer service. Documented need required.

WILLETT MEMORIAL ENDOWED SCHOLARSHIP - This endowed scholarship was established by a family member to honor her brother who was visually impaired. This scholarship is available to students who are enrolled at least half-time and have a minimum 3.0 GPA. Preference will be given to students who are visually impaired and have demonstrated financial need.

H. LORRAINE AND SHARON K. ZIMMERMAN MEMORIAL FUND – Eligible applicants must be in their first year of the nursing program, and have completed a minimum of 12 credit hours at KVCC with a 3.0 GPA. Must be currently enrolled for a minimum of 6 credit hours. Documented need required.

TRANSFER SCHOLARSHIPS

Scholarships through the State of Michigan

DEPARTMENT OF CONSUMER & INDUSTRY SERVICES

(Based on availability of funds, this scholarship is usually promoted in May/June for the up-coming fall semester. The deadline date to apply for this scholarship is usually within the first two weeks of July)

MICHIGAN BOARD OF NURSING SCHOLARSHIP - The Department of Consumer & Industry Services has established this nursing scholarship to promote associate degree and bachelor degree registered nursing education in Michigan. Eligible applicants must be a resident of the State of Michigan, intend to practice within the State of Michigan upon graduation, not be in receipt of a full scholarship from another source, and be enrolled in the Level II KVCC nursing program.

MICHIGAN COMPETITIVE SCHOLARSHIP -This scholarship is earned by demonstrated academic performance on the national SAT examination and documented financial need. Those found eligible may receive up to their demonstrated need or tuition charges, whichever is least. To be eligible, applicant must be a U.S. citizen, have been a continuous resident of Michigan from July 1st of the year preceding the academic year for which the scholarship is intended, be recommended by the high school as being of "good moral character", be a high school graduate or senior in "good standing" who will graduate by the end of the current academic year and plan to attend at least half-time at one of the eligible public or private Michigan colleges. Students need to have their FAFSA received by the State of Michigan by March 1, for first priority of scholarships.

MICHIGAN TUITION GRANT - Is available on the basis of demonstrated need to Michigan students attending non-public degree-granting Michigan colleges and universities. The Free Application for Federal Student Aid (FAFSA) is required for application. It is available through the guidance office at each Michigan high school and financial aid office and at each eligible, non-public, Michigan college and university. (NOTE: Students cannot receive both a State Competitive Scholarship and a Tuition Grant at the same time.)

Other State of Michigan Financial Aid Programs

SPECIAL POPULATIONS PROGRAM – The Carl D. Perkins Vocational and Technical Education Act of 2006 authorizes and funds this program which is called the Special Populations Program. This program provides financial aid and student services to eligible students. The goal of the program is to help students become financially self-supporting and personally independent. You may be eligible for this program if you lack job skills and are a member of one of the following population groups: Disabled, Economically Disadvantaged, Nontraditional Training and Employment Participant, Single Parent, Displaced Homemaker, Individual with limited English proficiency. Males and females are encouraged to apply. Applicants must be enrolled in a vocational education program.

TUITION INCENTIVE PROGRAM -The Tuition Incentive Program (TIP) is a high school completion program that offers to pay for the first two years of college and beyond for identified students who graduate from high school or complete their GED before age 20.

MICHIGAN EDUCATION TRUST (MET) - The Michigan Education Trust (MET) Program allows parents, grandparents, and businesses to pre-purchase and guarantee undergraduate in-state and in-district tuition for a child at any Michigan public college or university. Purchasers may guarantee 1, 2, 3, or 4 years of tuition. They may also choose to guarantee tuition solely at a community or junior college.

INDIAN TUITION WAIVER – The Indian Tuition Waiver Program provides free tuition for qualifying Native American students who are attending a public Michigan college/university.

POLICE OFFICERS AND FIRE FIGHTERS SURVIVOR TUITION ACT - Public Act 195 of 1996 provides for the waiver of tuition at public community and junior colleges and state universities for the surviving spouse and children of Michigan police officers and fire fighters killed in the line of duty. The program is intended to provide an educational benefit to the spouse and children of police officers and fire fighters who made the ultimate sacrifice for their communities and the citizens of Michigan.

Eligibility for the following programs are based on students completing the Free Application for Federal Student Aid (FAFSA)

GRANT PROGRAMS

The **Federal Pell Grant** is an entitlement program and is awarded based on the number of credit hours a student is enrolled for, the cost of attendance, and the Expected Family Contribution (EFC) number. The **Federal Supplemental Educational Opportunity Grant (SEOG)** is an additional grant program awarded per established guidelines to students showing greatest need for financial assistance. Priority is given to Pell Grant recipients.

EMPLOYMENT PROGRAMS

Students applying for financial aid may also qualify for the **Federal Work Study Program**. This program is designed to give students the opportunity to work and earn money to assist with educational expenses while enrolled in classes. Students who are awarded funds through the Federal Work Study Program are encouraged to participate in community service activities, especially the America Reads/America Counts program.

LOAN PROGRAMS

Student loans are one of four types of financial aid. Student loans are borrowed money that **must** be repaid, with interest. When used properly, student loans can be a good resource to assist with college costs. Before considering a student loan, you should exhaust all other financial aid types, such as grants, scholarships and work-study. To determine eligibility for these programs you must complete the Free Application for Federal Student Aid (FAFSA). The FAFSA can be completed online at www.fafsa.gov at no cost to the applicant. If you choose to borrow, we recommend exhausting federal loan eligibility prior to alternative loans.

As part of the Health Care and Education Reconciliation Act of 2010, signed into law by President Obama, the Federal Family Education Loan Program (FFEL) ceased on July 1, 2010. Kalamazoo Valley Community College processes Federal Stafford loans through the William D. Ford Direct Loan Program known as Direct Lending.

TYPES OF DIRECT LOANS

Direct Subsidized Stafford Loan: Eligibility for this need-based loan is determined by the Financial Aid Office based on your FAFSA results. Interest is paid by the federal government while you are enrolled at least half-time (minimum six credit hours a semester.)

Direct Unsubsidized Stafford Loan: This non-need based loan is identical to the Subsidized Direct Stafford Loan except that the student is responsible for the interest while in school. The student has the option of paying the interest or having it capitalized which means the lender may add the accrued interest to the principal you owe.

Direct PLUS Loan: - This loan program offers a non-need based source of loan funds available to parents of dependent undergraduates. The interest rate is fixed at 6.31%. There is no federal interest subsidy. Under the Direct PLUS Loan when the borrower is a parent, repayment of interest and principal must begin within 60 days of disbursement of the loan. The parent may borrow up to the cost of education minus other aid.

CONSOLIDATION LOAN: - Stafford Loans, Perkins Loans and Health Profession Student Loans could be eligible for consolidation. The Interest rate is the weighted average of loans selected for consolidation. Consolidation loans are not eligible for federal interest subsidy. The borrower is responsible for the interest. Length of repayment is contingent upon the amount of indebtedness involved. Students interested in loan consolidation should contact Direct Lending at www.dl.ed.gov.
