Other services may be provided to assist Veterans in starting their own businesses or independent living services for those who are severely disabled and unable to work in traditional employment. In general, a veteran must be 20% service-connected and within twelve years of separation to qualify for VR&E. However, all veterans are encouraged to apply as certain exceptions can be made.
